**Greetings from Washington**... Things are hopping here at CSIS. The activity rate is as high as ever and we have come through the worst of the recession largely intact. To complicate things, we lost a good number of people who have joined the new Administration, but we have also

recruited excellent new people. Things are looking good here at the Center and we are on the move.

**Our New Building**... Since I last wrote, we have made great progress on the new building. We are at the final stages of design work. We cleared the important zoning hurdles this summer with the District of Columbia's Zoning Commission and are working hard to raise money to build the building. That part of the process is going remarkably well, given the state of the economy.

**NPT Review Conference...** Two years ago, we launched an ambitious effort to bring together France, Britain and America on nuclear issues in anticipation of the Non-Proliferation Treaty Review Conference next May. We started with a classic "track two" approach (Track 1 is government to government. Track 2 is think tank to think tank dialogue and Track 1.5 is a mix of the two), but that quickly turned into a Track 1.5 approach. We met last week with government officials and think tank policy experts from all three countries and worked line by line through a very good joint declaration. This is CSIS at its best. We got in front of the issue, created a constructive and neutral space for collaborative thinking, and have a process to hand it to the government for action.

**Food Security Task Force**... Johanna Nesseth and Steve Morrison are working on a new phase for our food security project. We met last week with senior leaders at the State Department, which is leading an effort for the U.S. government on food security.
