If a civilian is to be nominated into any of these four positions, they would have confirmation hearings sequentially by the Senate Select Committee on Intelligence, followed by the Senate Armed Services Committee, and lastly, pursuant to the order of January 7, 2009, to be sequentially referred to the Committee on Homeland Security.

***As incumbents, Ms. Sapp and Adm. Rogers continue to serve and only when a new civilian nominee is named will the above confirmation process be followed.
